Pg 4 – Transfers of ITC funds to the Kentucky Democratic Party

The vast majority of funds for payroll and other administrative expenses are paid from the federal account. Attached are agency reports documenting these expenses.

ITC funds are reported to both KREF and to the FEC. Protocol in the past was to pull the data from the disclosure software and then enter it into the KREF report manually, which required entering it as FEC activity and then remembering to change the designation back to non federal. With the new KREF reporting system, data is entered directly from the Quickbooks check register rather than from NGP.

*Please note that all invoices are scanned and saved. Prior to 2018 they were saved to the hard-drive of the computers we used at the time. One desk top and one lap top on which they were stored died. They are now saved to the cloud and to Google Drive.

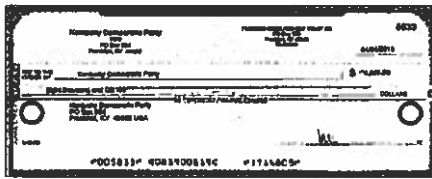
